- **3.** Tender documents may be downloaded from website and submission of Technical Bid & Financial Bid will be done as per time schedule.
- 4. The FINANCIAL OFFER of the prospective tenderer will be consider only if the TECHNICAL BID of the tenderer is found qualified by the 'Tender Evaluation Committee' formed by the Chairman, Bishnupur Municipality. The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of qualified tenderer will be displayed in the website.

5. Eligibility criteria for participation in the tender:

i. The prospective tenderer shall have satisfactorily completed at least in a single same nature of work during the last 5 (five) years from the date of issue of this notice and having a magnitude of 40% (Forty percent) of the amount put to tender.

- ii. Intending tenderers should produce credentials of 2(two) similar nature of works, each of the minimum value of 30% of the estimated amount put to tender during the last 5 (five) years from the date of issue of this notice.

- iii. Intending tenderers should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (i) above.

N.B.: No credential will be considered as valid unless it is supported by work order (price schedule or BOQ of work if any) and completion certificate mentioning the date of completion issued by the competent authority not below the rank of Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government undertakings, Statutory / Autonomous bodies constituted under the Central / State Statute. The completion certificate should indicate the value of the work (equal to booked expenditure).

iv. In case of running works, only those tenderers who will submit the satisfactory running work from the concerned Executive Engineer or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work in progress satisfactorily and also that no penal action has been initiated against the executed agency i.e.the tenderer.

- **6.** The successful tenderer shall establish field testing laboratory equipped with requisite instruments in conformity with relevant code of practice and technical staff according to the requirements of works to be executed.
- 7. Constructional Labour welfare Cess @ 1% (one percent) of cost of construction will be deducted from every bill of the selected agency, Royalty & all other Statutory levy / Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.
- **8.** Adjustment of Price (increase or decrease) Vide Notification No.23-CRC/2M-61/2008, Dated:13.03.2009 & Notification No. 38-CRC/2M-61/2008 Dated 20.04.2009 shall not be applicable. Since B.O.Q for the works under this N.I.T. the tenderer shall quote their rate (percentage above / below / at per) accordingly considering that no escalation and / or price adjustment will be allowed by the department there to under any circumstances.

- **9.** No Mobilization Advance and Secured Advance will be allowed.
- 10. Agencies shall have to arrange required land for installation of Plant & Machineries, (specified for each awarded work, shoring of materials, labour shed, laboratory etc at their own cost and responsibility nearest to the work site.
- 11. Agencies shall have to arrange land for erection of Plant & Machineries storing of materials, labour shed, laboratories etc at their own cost and responsibility.
- 12. All materials required for execution of each work (as per BOQ) to be produced and supplied at site by the contractor at his own cost.
- 13. Bids shall remain valid for a period not less than 120 (one hundred and twenty) days from the last date of submission of Financial Bid / Sealed Bid. If the tenderer withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited without assigning any reason thereof.
- 14. All materials required for the proposed scheme including bitumen (all grade) bitumen emulsion cement & steel shall be of specified grade & approved brand in conformity wiyh relevant code of practice (latest revision) & manufacture accordingly & shall be produced & supplied by the agency at their own cost including all taxes. Authenticated evidence for purchase of bitumen, bitumen emulsion , cement & steel are to be submitted along with Chalan and test certificates in the event of further testing by the Engineer-in-charge, then such testing from any Government approved Testing Laboratory shall have to be conduct by the agency at their own cost. - 16. There shall be no provision of arbitration hence C.I. 25 of Form-'291(II)' is omitted vide notification no. 558/SPW date. 13.12.2011 of Secretary, to the government of West Bengal.
- 17. **DEFECT LIABILITY PERIOD**: Vide Notification No.5784-PW/L&A/2M-175/2017 dated12.09.2017 & LED should be warrantee for 5 years (20% security will be deduct from the bill which will be realised in five equal installments in five years).
- **18**. **Acceptance of Bid:** The "Chairman, Bishnupur Municipality" will accept the Bid on recommendation of the Municipal Engineering Directorate, Bankura Division. He / She does not bind himself / herself to accept otherwise the lowest Bid and reserves to himself / herself the right to reject any or all of the Bids received without assigning any reason thereof.
- **19. Escalation of Cost:** There will be no escalation in cost for materials or labour and the contract price mentioned in the contract stands valid till completion of the contract, and other obligation, if any.
- **20.** Name & address of Engineer-In-Charge (EIC) of the Work: Sri Somnath Roy, S.A.E., Bishnupur Municipality.

- **21.** Execution of Work: The Contractor is liable to execute the whole work as per direction and instruction of Sri Somnath Roy, S.A.E., Bishnupur Municipality.
- **22. Payment:** Payment will be made to the successful Bidder by the "Chairman" Bishnupur Municipality periodically on availability of fund & any deductiction of bill as per W.B. Financial Current Guidlile.
- **23. Influence:** Any attempt to exercise undue influence in the matter of acceptance of Bid is strictly prohibited and any Bidder who resorts to this will render his Bid liable to rejection.
- **24. Earnest Money:** The amount of earnest money @2% (two percent) of the Estimated Amount put to tender in the shape of RTGS/NEFT of any nationalized / scheduled bank drawn in favour of "Chairman, Bishnupur Municipality payable at Bishnupur against the work. This clause is also applicable for all categories of applicants except those are exempted as per prevailing Government Order. Retention money towards performance security amounting to 8% or as per any current govt norms of the value of work shall be deducted from the running account bill.
- **25.** The tenderer at the Tenderer's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, the cost of visiting the site shall be at the Tenderer's own expense.
- **26.** The intending tenderer shall clearly understand that whatever may be the outcome of the present invitation of Bids no cost of binding shall be reimbursable. The Chairman, Bishnupur Municipality reserves the right to reject any application for purchasing Bid documents and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Tenderer at the stage of bidding.
- **27**. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in Instructions to Tenderer before bidding.
- **28.** In case of Ascertaining Authority at any stage of tender process or execution of work necessary registered irrevocable power of attorney is to be produced.
- **29.** All intending tenderer are requested to be present in the chamber of the Chairman, Bishnupur Municipality during opening of the tender to observe the tender opening procedure.
- **30.** CONDITIONAL and INCOMPLETE TENDER will not be accepted under any circumstances.
- **31.** Necessary requirement of principal machineries and laboratories which must be possessed either owned or leased by the tenderer. [Non-statutory documents]

Other modern machinery required for the work to be executed by Mechanical means as far as practicable. Necessary certificate should be submitted for authenticity of own / leased machineries.

Qualification Criteria

II. Financial capacity of a bidder will be judged on the basis of working capital and available bid capacity as mentioned in the N.I.T. to be derived from the information furnished in (Section - B) i.e., Application for Pre-qualification & Financial Statement. If an applicant feels that his / their Working Capital beyond own resource may be insufficient, he / they may include with the application a letter of guarantee issued by a nationalized bank / authorize bank of **RBI** to supplement the applicant. This

letter of guarantee should be addressed to the Tender Inviting / Accepting Authority and should guarantee duly specifying the name of the project that in case of contract is awarded to the Bidder, the Bidder will be provided with a revolving line of credit. Such revolving line of credit should be maintained until the works are taken over by the Engineer-in-Charge / Employer. The audited Balance sheet for the last 3(three) years, net worth, bid capacity, etc. are to be submitted which must demonstrate the soundness of Bidder's financial position, showing long term profitability including an estimated financial projection of the next two years.
